Position Summary

The Child Care worker is responsible for ensuring the children in the care center are cared for according to agency standards. The child care worker must be dedicated to representing Explorers Academy positively to the community. The Child care worker must be committed to providing inspiration to children and outstanding customer service to families.

DUTIES AND RESPONSIBILITIES

On a daily basis the Child Care worker will be responsible for:

Assisting with the weekly execution of program activities.
Ensuring a safe environment for the children in the center.
Maintaining a clean healthy environment in the center.

ESSENTIAL SKILLS

- Must maintain self-control and manage difficult or emotional situations with tact and professionalism.
- Must maintain confidentiality.
- Must communicate clearly, both orally and in written format.
Must demonstrate respect and sensitivity for cultural, racial and economic differences.
- Must treat others with respect and consideration to foster a teamwork environment.

EDUCATION AND EXPERIENCE REQUIREMENTS:

- Must obtain CPR/First Aide certification (on the job training)
- Must complete state day care licensing training (on the job training)
- Must pass background checks.

PHYSICAL DEMANDS:
